In 2025, Brackenridge Park Conservancy achieved significant progress in advancing park enhancement, community engagement, and organizational growth. Key accomplishments included the launch of the Nature Playscape project, an inclusive, nature-based play area developed with community input and designed to support universal accessibility. The Conservancy also strengthened its operational capacity by relocating to a larger office space, enabling a growing team to collaborate more effectively and better support the organization's expanding programs and initiatives. Marketing and outreach efforts also demonstrated strong momentum, including the launch of a new website, a 50% increase in news coverage related to the park, and a 20-30% increase in social media followers. Fundraising efforts were equally successful, exceeding the capital campaign goal with more than \$4.7 million committed to support free community programming and ongoing park improvements. Community participation remained central to the Conservancy's impact throughout the year. The organization hosted more than 22 events, welcoming over 19,000 people into the park and strengthening Brackenridge Park's role as a dynamic gathering place for residents and visitors. Signature events, including Party in the Park: Miraflores, Polo in the Park, and Family Fishing Day, advanced cultural celebration, wellness, and environmental stewardship. The volunteer program also completed a strong inaugural year, supporting 33 events and contributing 2,429 service hours. These efforts resulted in the removal of 1,172 bags of trash and provided critical support for large-scale community events. Through continued wellness programming, educational tours, and partnerships with local organizations, the Conservancy further reinforced its commitment to preserving Brackenridge Park's historic and cultural legacy while expanding access, engagement, and enjoyment for the San Antonio community.
